

Terms and conditions

Reservation:

Requests for availability or reservation, or possible modifications, must be the object of an email. Our confirmation of reservation will also be given in writing. The telephone exchanges on the availability of a reservation are purely informative.

Validation of a reservation:

The stays are guaranteed only by the reception of a deposit whose amount corresponds to 50% of the total amount of the stay and deductible from the pay of the invoice. The deposits will be cashed upon reception. The deposits will have to be paid at the latest within 5 days upon receipt of confirmation. The balance of the invoice must be regulated at the latest 2 weeks before the beginning of the stay.

You can regulate these deposits and balances in 3 ways:

- By bank check (at the order of 'Le Barailot') to join with **the reservation contract (only for France)**.

- By credit transfer without expenses (faster for a guaranteed reservation/for the expenses please check this point with your bank).

- By bank/credit card (subject to acceptance). The holder of the chart explicitly gives the authorization to Le Barailot to deduct the deposits and balances agreed under the present conditions of sale.

In the event of cancellation of stay, the holder of the chart authorizes Barailot if necessary to take the deposit possibly not taken and reservation balances, according to methods' envisaged with the cancellation conditions.

It is starting from the cashing of a deposit or communication of your N° of credit card that your reservation will be firm. The payment of a deposit implies the acceptance of these general conditions of sale.

In the event of final cancellation, the versed deposits remain definitively with Le Barailot.

Hour of arrival:

The rooms are available as of 16h30.

Thank you for not arriving after 22h30 and to prevent for every arrival after 19h30.

Time of departure:

The time of departure of the rooms must be done before 10h30.

Change of rooms: Without the customer not being able to prevail himself of any allowances, the owner reserves the possibility of changing the room initially reserved by the customer by a room of the same or of higher capacity. In such a case, the cost of the reservation remains unchanged.

Consumption: The consumptions not included in the breakfasts and meals will be invoiced in supplement the day of the departure on the following bases:

- fresh drink: 2.00 euro
- coffee or tea: 1.50 euro
- glass of wine: 2.00 euro
- aperitif: 3.00 euro
- glass of digestive: 5.00 euro
- bottle of champagne: 25.00 euro
- wine list available at reception – price range from 8.00 to 20.00€

Meals and table d'hôte: It is necessary to book your table in the restaurant or table d'hôte for lunch, dinner, the latest with breakfast.

Table d'hôte adults:	27.00€
Table d'hôte adults, without wine:	25.00€
Table d'hôte + 12 years:	15.00€

Table d'hôte + 6 years:	7.50€
Table d'hôte - 6 years:	5.00€

Gift vouchers Le Barailot:

Methods of use:

Gift vouchers and the conditions of sale of Le Barailot are accepted by the customer and the recipients of the gift vouchers.

Notice gifts vouchers Le Barailot: Vouchers are sent after the integral payment of the amount of the order.

The gift voucher is regarded as a means of payment, the conditions of cancellation described under our conditions apply to the gift vouchers which will be cancelled in whole or part according to times' of cancellation.

Recipient of the gift vouchers do not have to pay a deposit to guarantee their reservations. The gift voucher acts as deposit.

Pets:

Except agreed by 'Le Barailot' at the time of the reservation, pets are not accepted.

Children:

The presence of the swimming pool, make that the children evolve/move within Barailot under the single responsibility of their parents. The swimming pool is equipped with an alarm up to standards but is not supervised and children of less than 12 years, and/or not knowing to swim, cannot remain in swimming pool area without the presence of a relative.

Art of living:

The respect of a certain art of living is requested from all the hosts to guarantee the quietude of the guest house and the comfort of its hosts. Moreover, it is not allowed to smoke in the rooms. The customer commits himself respecting the instructions and guidelines mentioned in the scrapbook in the rooms and in the present general conditions of sale. The customer commits himself to return the rooms in perfect state at the end of its stay and to declare, and be assuming financially, any possible degradation for which it could be responsible on the property.

Cancellation: If cancellation intervenes more than 15 days before the beginning of the stay, the deposits remain sure with 'Le Barailot'. If cancellation intervenes less than 15 days before the beginning of the stay, the deposits remain sure in Le Barailot which will claim and/or take the balance of the price of the hiring or the stay if the hiring or the stay remains vacant following cancellation.

If the customer didn't prevent for a late arrival and the customer does not appear before 7.30 p.m. the day envisaged of the beginning of the stay, Le Barailot can have its rooms. The deposits remain sure in Barailot which will claim and/or take the balance of the price of the hiring or the stay if the hiring or the stay remains vacant following cancellation.

In the event of stay/hiring curtailed, the price corresponding to the cost of lodging remains completely sure with 'Le Barailot'. Le Barailot will claim and/or take the balance of the price of the stay.

In the event of cancellation of a reservation by Le Barailot, Le Barailot is committed to inform the customer of cancellation of his reservation by any means and refunding the deposits paid by the customer under 14 days. In the event of cancellation, the customer can claim no compensation on behalf of Barailot and gives up prevailing himself of any damage.

Option insurance We urge the tenant to subscribe cancellation insurance with its insurer. In general, the covered risks are: tenant's risks, restitution of the deposit due to only justified cancellation, interruption of stay or differed from entry. We remain at the disposal of your insurer for all information necessary to the catch of insurance.

The present conditions of sale can be modified without notice. The acceptance and the respect of these conditions of sale are famous assets as of the payment on the accounts.

In accordance with the law of January 6, 1978, you profit from a right of access and of correction to the data concerning you. Le Barailot is committed not transmitting any information that you communicated to him at other companies or organizations.
